Church Seating – Church and Banquet Chairs**

**25 Year Steel Frame Warranty** The entire ChurchPlaza steel frame (not just the welds) carries a 25 year warranty against failure when seating is used for traditional seating activities. Any frame found to be defective by ChurchPlaza will be repaired or replaced at our option.

**25 Year Structural Seat and Back Warranty** Seat and Back foundations are warranted for 25 years against structural failure or breakage under normal use. Our ½" plywood seat and back are designed to exceed BIFMA standards. Reminder, chairs are not designed to be used as step stools, ladders, or supports for construction projects.

**Foam Warranty** The foam is guaranteed not to wear or break down to a point of affecting the seat comfort or loosening of the fabric for a period of 10 years.

**Upholstery Warranty** ChurchPlaza's Quality Fabrics are warranted for 10 years against ordinary wear when used in a sanctuary ministry or comparable application within the continental United States and for 3 years when used outside of the continental United States in a worship facility or comparable application. Sewing workmanship is warranted for 5 Years with the exclusion of Card Pockets and Book Pouches due to vulnerability of unintended misuse. We do not warrant fabric against cuts, tears, burns, normal fading, Ultra Violet Lighting, outdoor use and/or exposure to sunlight.

All upholstery fabrics and foam used in the manufacture of ChurchPlaza chairs are warranted by the respective fabric or foam supplier and ChurchPlaza. We reserve the right to receive photos of the problem and to have a defective chair returned to us at our expense.

**Warranty does not apply** to any product, which has been altered or subjected to misuse, negligence or accident. ChurchPlaza's obligation under this warranty is limited to credit for or replacement of the defective item.

**Who is covered by our limited warranty?** Our limited warranty only covers the original purchaser of our furniture. It does not cover any subsequent owner or other person to whom you sell or give our furniture.

Pulpit furniture is subject to manufacturer warranty. The vendor, ChurchPlaza, acts as an intermediary in the distribution of this product and does not independently provide any warranty.

**Are there other limitations to our warranty?** The remedies described above are your sole and exclusive remedies and represent our entire liability based on, related to or connected with your purchase and use of our furniture.

In no event will our liability ever exceed the actual amount paid by you for the defective furniture nor will we under any circumstances be liable for any incidental, consequential, special, punitive or exemplary losses or damages.

Some states do not allow the limitation or exclusion of incidental, consequential or other types of damages, so the above limitation and exclusion may not apply to you.

**Does state law provide me with any other rights?** This limited warranty gives you specific legal rights and you may also have other rights which vary from state to state.

**TO THE EXTENT PERMITTED BY ALL APPLICABLE LAW, YOU ASSUME ALL RISK OF INJURY THAT RESULTS FROM THE USE OF OUR FURNITURE.**
